

# Residents' Survey

**Results report** 

#### 1. Purpose of Report

The purpose of this report is to present the key confirmed results from the recent Moreton in Marsh Parish Neighbourhood Plan Residents Survey – March 2021.

Further analysis of the results and presentation of all the free text comments can be found in the document 'Community survey open-ended questions responses' These have all been noted and incorporated in the report, as well as being used to shape the policies in the Neighbourhood Plan.

#### 2. Methodology

The aims of this questionnaire were to capture the Vision and Aims for the parish over the next 10 years.

#### <u>Design</u>

The\_design of the questionnaire was based on the following;

 Inputs received from the parish at various Drop In events and workshops held around the town since February 2019. From these sessions key themes, opportunities and issues were identified.

The questionnaire was developed consisting of the following sections (65 questions);

- 1. You and your Household 16 questions
- 2. Housing 3 questions
- 3. Employment & Local Economy 14 questions
- 4. Getting around Moreton-in-Marsh 12 question
- 5. Natural & Built Environment 8 questions
- 6. Climate Change & Energy 5 questions
- 7. The Community—5 questions
- 8. Final Thoughts 2 questions

Originally the questionnaire was to be rolled out in February 2021 with a return deadline of 19<sup>th</sup> March 2021. This return was extended by a month due to lockdown causing delays in distribution.

#### Respondents

A printed copy of the resident's survey was delivered to every household in the Moreton-in-Marsh parish. In addition to this, emails were sent to all residents on the neighbourhood plan mailing list with a link to the electronic version of the survey. A link to this was also put on the Moreton2031 website, Nextdoor, Facebook and the Moreton-in-Marsh Town Council website. Posters were also put up in key locations around the town. It should be noted that each household had a unique reference number to use on their return, these could not be used multiple times.

#### **Distribution**

Questionnaires were distributed as follows;

- via SurveyMonkey through an email invitation
- via paper copies hand delivered by members of the working group
- delivered via Royal Mail
- Upon request of re

SurveyMonkey was closed to any further online responses on the 19<sup>th</sup> April 2021.

At this point the numbers of questionnaires returned were;

- 311 via SurveyMonkey
- 519 via paper copies returned to the Town Council Offices. A further 5 were returned within the following week and were included in the results.
- There are approximately 2,400 households within Moreton-in-Marsh parish. Therefore, the response rate calculates to be 35%.

#### Aggregating all the results

One of the advantages of using SurveyMonkey is that paper copies can be added to the results by entering them manually into the same survey. This means the analysis produced will contain all the responses.

When completing the questionnaire online, using SurveyMonkey, validations can be used to ensure that questions get a response and that incorrect or nonsensical answers can be avoided. However, when completing a paper questionnaire there are no validations and responses can be skipped and incorrect answers can be given. This can give rise to corrupted results and analysis. As a result of this when these paper copies were entered into SurveyMonkey incorrect answers were identified and the following corrections made;

- Where no answers entered treated as a 'Skipped' question; not counted in any results or analysis
- Where incorrect answers entered that cannot be made sense of; e.g. where more selections have been made than allowed – also treated as a 'Skipped' question; not counted in any results or analysis
- Where incorrect answers entered but are less selections than requested also treated as a 'Skipped' question; not counted in any results or analysis
- Where there were multiple answer options (i.e. very happy/happy/neutral/unhappy/very unhappy), the results have been calculated using a 'weighted average'. This means a score is given to each option (e.g. very happy-5; happy-4...very unhappy-1). This is then used to calculate an average figure for the answer, which can be used in graphs etc.

#### **Issues Arising**

When entering the paper copies of the survey onto SurveyMonkey, a small number of issues were highlighted:

- Questions 3; 4; 5 & 8 had 3 columns of answers. The check box for the left column was closer to the answers for the right column, which could result in respondents checking the wrong box. This could be checked by comparing question 5 to question 10, which both related to ages. 11.5% of respondents didn't indicate a person of the corresponding age between the two questions.
- Question 27 on SurveyMonkey did not allow respondents to mark the same answer more than once. Unfortunately, this makes the results unusable, as there is a more-than-fair likelihood that respondents may have wished to use the same answer twice.

Although the response rate was high, the age groups of the respondents is tilted towards the older population. In the 2011 census, 33% of the residents in Moreton-in-Marsh were over the age of 60. In the residents survey, 43% of the people living in the respondents household were over 60. There are converse results in younger age groups. This should be taken into consideration when reading the results and the SG will also ensure that community engagement is taken in the future, targeting the unrepresented age groups.

#### **Next Steps**

The results of this survey will be used to identify the challenges faced by the community in Moreton-in-Marsh. From this, we will be able to identify any issues which can be addressed through the Neighbourhood Plan. When we have identified these challenges, we will work on creating a Vision and Objectives to address these challenges. At this stage, we will consult with the community again, to ensure we are on the right track!

We will also use the results to identify other important topics and create 'Community Aspirations'. These will be projects for the Town Council to address but cannot be addressed through the Neighbourhood Plan.




#### Summary

- Top 3 concerns about Moreton-in-Marsh: HGV Traffic and congestion; Excessive population growth; Loss of green space














### Q9. Number of people in household: (no corresponding census data)









(residents were asked to choose 5 topics and rank them 1-5)






Q16. Five words that you would like Moreton-in-Marsh parish to be described as in 10 years' time:

#### Housing

- ▶ 65% would not support the NP identifying further housing sites. 15% didn't know.
- ➤ 24.5% of renters would support NP identifying housing sites. 15.5% of home owners would support identification of sites.
- Most support for 'Homes built to higher environmental standards' (60%).


  Second: 'Homes designed with accessibility for older/disabled people'.

- Least support for Open market housing.




The Residents survey explained the Cotswold Local Plan has allocated strategic housing sites for approximately 203 homes for Moreton-in-Marsh.


Neighbourhood Plans can allocate their own sites for development, which specifically reflect local need.

Q17. Residents were asked if they would support the identification of further sites for housing within the Neighbourhood Plan: Answer skipped: 4%










#### **Employment and our Local Economy**

- nearly 50/50 split of working/not working (which reflects age of respondents). Of the respondents who were over 75, 90% were not working.
- most popular method of travel to work car/van. Those who work within 5 miles of Moreton-in-Marsh, 83% travel by car/van (compared to 62% overall). Those who work within Moreton-in-Marsh 47% walk to work, 40% car/van
- > 57% would support NP identifying further land for employment use
- ➤ 65% would support the NP identifying buildings for employment use within the town centre
- Medical facilities very highly regarded by respondents-Top Three: Doctors/Hospital/Pharmacies
- Most used facilities: grocery shops (65% use them frequently). This question needs to consider the age of respondents, which may skew responses. E.g. 76% of respondents never use the pre-schools, which reflects the age of respondents (43% over 60 yrs old)
- > 81% respondents think the core town centre should be kept the same size.
- ➤ 38% want town centre protected; 49% believe Yes, some protection but recognise things change and we need to let this happen



#### Q20. Are adult members of your household currently working?




Q21. For each adult household member that is in employment please tick how far they travel to work?




Q22. For each adult household member who is in employment please tick to indicate how they usually travel to work

#### Q23. Do you think there are enough jobs in Moreton-in-Marsh?




Q24. Would your household support the Neighbourhood Plan identifying further land for employment use? Answer skipped: 4%


# Q25. Given the increase in home working as a result of Covid-19, would your household support the creation of a work hub in the town



Q26. Would your household support the Neighbourhood Plan identifying buildings for employment use within the town centre: Skipped answer: 8%





Q28. Does your household visit the Tuesday market?




## Q29. To what extent do the following facilities in Moreton-in-Marsh meet your household needs?

The graph below shows the percentages of opinions-however it is important to note that in this question, the number of respondents who marked 'no opinion' or 'Do not have a need for these facilities' or left all options blank was considerable. In 7 of the facilities, these accounted for over 50 percent of the responses. This is most likely due to the age demographic of the respondents and this should be taken into account when considering the results.




# Q30. Thinking about the same facilities listed above, how often do you use the following facilities in Moreton-in-Marsh?


As with the previous question, the graph below shows the percentages of opinions-however it is important to note that in this question, the number of respondents who marked 'never or 'Haven't used but would consider in the future' or left all options blank was considerable. In half of the facilities, these accounted for over 50 percent of the responses. This is most likely due to the age demographic of the respondents and this should be taken into account when considering the results.







#### Getting around Moreton-in-Marsh

- ➤ 66% of respondents walk when they want to visit Moreton-in-Marsh town centre
- > 71% of children of respondents walk to pre-school or school
- > 79% would support more dedicated walking and cycling routes within the town
- safer routes would encourage 29% of respondents to walk or cycle more,
   21% would like better condition of routes
- > 59% of respondents think it is fairly or very safe to walk/cycle around the town. 3% think it is very unsafe
- > 60% feel current public transport options meet their need
- 63% believe the public rights-of-way around Moreton-in-Marsh are important or very important
- There were over 220 suggested upgrades or new routes-see separate document



#### Q34. If visiting the town centre, how does your household generally get there?




Q35. If you have children that attend nursery or school in Moreton-in-Marsh how do they usually get there?




Q36. Would your household support more dedicated walking and cycling routes within the town? Skipped answer: 8%




Q37. What would encourage members of your household to walk or cycle more?




Q38. In general, how safe do you think it is to walk/cycle around town?




Q39. What do you think about the amount of traffic in town? Skipped answer 4%



Q40. If you drive into the town centre, how often can you easily find a car parking space? Skipped answer 17%








- nearly 50% of respondents are 'satisfied' with the parks, open spaces and green spaces in Moreton-in-Marsh
- Respondents rated accessibility highest with regard to the existing parks and open spaces. Play equipment and facilities for older children had the lowest ratings
- Fond; High Street Greens; Queen Victoria Gardens. All 12 suggested spaces received over 50%
- ➤ 56% of respondents believe the amount of green space should be increased. Over 250 suggestions of how this could happen were received!
- > 73% of respondents believe biodiversity in Moreton-in-Marsh is somewhat important or very important
- 175 suggestions of locations to introduce or enhance biodiversity were received
- ➤ 67% of respondents believe the historic buildings in Moreton-in-Marsh are very important


Q46. How satisfied is your household with parks, open spaces and green spaces in Moreton-in-Marsh? Skipped answer 7%




Q47. Thinking about our existing parks and open spaces in the town, how does your household rate the following factors? (please rate each factor)




Q48. Are there any open or green spaces that you think are important to the town and should be protected from future development? (respondents could tick all that apply)




Q49. Should we increase the amount of green space in Moreton-in-Marsh? Skipped answer: 13%


#### Climate Change and Energy

- ➤ 24% strongly agree and 38% agree with the statement "The town should aim to be self-sufficient in locally generated renewable energy, as far as possible"
- Roof-based solar panels and ground and air-source heat pumps receive the most support with just over 50% of respondents supporting each of them
- The 2 statements "Renewable energy projected should be supported as long as they are partially owned by the community, such as a joint venture with a commercial energy provider" and "Renewable energy projects by commercial developers should be supported, as long as they are required to make some financial benefit payments to the town annually" both received the highest support with 44% of respondents agreeing with each of them
- > nearly 60% of respondents agree with the statement "I feel that climate change is a risk to me and my family". Just over 40% disagree with the statements "My property is at risk of flooding" and "I struggle to keep my home warm in the winter"
- Over 320 suggestions for actions households can take to reduce carbon emissions were received






Q55. Please tick all forms of renewable energy that your household would support the Neighbourhood Plan encouraging in its policies?



- > 78% of respondents feel there is high/good/some community spirit in




Q59.Generally, how satisfied is your household with the local services and amenities in Moreton-in-Marsh? Skipped answer: 17%
